# **November Public Meeting Minutes**

November 12, 2015 | 127 Memorial Hall | 6:00 pm

# I. CALL TO ORDER & WELCOME

The meeting was called to order at 6:01 pm.

# II. GUEST SPEAKER

Guest speaker was Dr. Sue Groff, from Director of the Office of Equity and Inclusion to discuss sexual misconduct information and updates. The location of the policy is now under 4-115 under Personal Policies and on sexual misconduct website at http://sites.udel.edu/sexualmisconduct/. It applies to all faculty, students, and staff. The Faculty Senate Commission Update report is still pending, which collaborated with IR on campus climate survey and hope to work on faculty education. Dr. Groff outlined the Title IX Governance Structure, which includes OEI, an oversight committee, a case advisory board, education/prevention/training for students, policy and communications, and athletics.

Under the new policy, when a report is filed, the Title IX coordinator will log it and reach out to the complainant, providing information regarding resources (class schedules, living arrangements, etc.). This does not initiate an investigation. The Title IX coordinator then works to resolve the case, taking it to the Case Advisory Board if necessary, confidentially if possible. Finally, a decision to proceed may include: no further action, action if the complainant chooses to do so, action whether or not the complainant chooses to participate (i.e. in the case of a safety issue). If action is taken, the Coordinator will meet with the respondent, investigators will conduct the investigation, and will be reviewed within 30 days (with a notification if time will be longer). Afterward, the Office of Student Conduct Sanctioning Panel, which will include a peer, will review the report. Respondent and complainant will be allowed to appear before the panel before a sanction is decided and both parties are notified in writing.

As an aside, graduate students interested in training to serve on the OSC Sanctioning Panel should contact President Brodie or Dr. Martin.

Appeals of the outcome may be made within five days of the outcome, in writing. Appellate board will consist of one faculty member, one grad student (for grad student complainants), and one staff member who will make a final decision.

A member asked at which point is the incident reported to the authorities. Dr. Groff replied that at no point is she required to report to the authorities. OEI is responsible for due process on the University's end, it is up to the complainant to decide which route they choose, the university or law enforcement.

If anyone violates the policy, even a tenured professor can be dismissed.

As far as retaliation and social repercussions, retaliation is against the policy and any form of this should be reported. The investigator model means that the complainant does not have to interact with the respondent.

    - It is possible that an ad hoc committee could become a standing committee. We
      must remember that we are voting regarding some ad hoc committees that don't
      even exist yet.
    - Concerns that it might miss the actual issue of whether or not the committee is still doing what it set out to do. Is this actually a problem the GSG is having? We recognize that it might take more than a year to get a GSO off the ground.
    - Additionally, it has been recognized by some members that due to turnover of senators, it is important that ad hoc committees be able to maintain status, even when no new senator knows what is going on.

The Senate will not consider a second request for renewal. This amendment requires at 2/3 majority. There was a motion to approve the motion was seconded. Motion fails 22 for, 17 against.
