# The following proposed bylaw changes were approved by the Steering Committee at its February 9 meeting:

Background info: "The purpose of this club shall be to welcome newcomers to the University community, promote social, informational and service opportunities for its members and to further the interests of the University of Delaware."

The proposed changes are in bold italics.

\*\*\*\*\*

#### Article II-Membership

A. Membership is open to women employed by the University of Delaware (UD), current and retired; Wives, female domestic partners and widows of UD employees, current and retired; Female UD graduate students and the wives or female domestic partners of UD graduate students

Change to:

Membership is also open to any woman who supports the University of Delaware Women's Club's (UDWC) purpose and who wants to participate in UDWC activities.

Article X- Woman of the Year

A- Eligibility - same

(Add B)

B- Criterion: The Woman of the Year shall have made substantial volunteer contributions to UD or to the broader community.

C- Deadline - was part B, same

D- Vote; was part C, same.

Article XI- By-Law Amendments

By-laws must be approved by the majority of the membership and take affect (change "affect" to "effect") the following year. Amendments can be made with a 2/3 vote of the executive board.

## The rationale for the proposed changes:

#### Article II- Membership

There are many women who would like to join us and participate in our activities who are not direct members of the UD community. Many of them are alumni, married to alumni, daughters and daughters-in-law of faculty, for example. We are a small group of women who could benefit from new members who support our purpose. (see Background info.)

#### Article X - Woman of the Year

The bylaws are quite clear about the Woman of the Year Eligibility, Deadline and Voting. But it does not address what the award is for. This amendment clarifies the purpose of the award.
