### **Mary Allen Hewes Ancestors**

Mary Allen was mentioned in The Lineage from George Hewes to Abigail Hewes Maxham as the wife of George Hewes, where it was noted that she was the daughter of William and Ann (Goodale) Allen of Salisbury. The Following pages are taken from *The Old Families of Salisbury and Amesbury Massachussetts*, by David W Hoyt, 1897. They give the lineage of Mary Allen back to her ancestors who travelled to Plymouth Colony from England.

On the first page from the book (Genealogy) Mary Allen Hewes' father is given as William Allen who appeared in Salisbury in 1640. His first wife Ann Goodale died in May of 1678, and William Allen married again after the death of his first wife. William Allen died on June 18, 1686. The third child of William and Ann Goodale Allen was Mary, who was born July 29, 1644. Since Ann Goodale Allen died in 1678, this must be her daughter. It is specifically noted that Mary Allen married George Hewes.

The first page from the book also notes that Ann Goodale was the daughter of Richard Goodale. Pages 176 and 177 from the book show that Richard Goodale [or Goodell] first appeared in Salisbury from Yarmouth, England about 1638 and he died in September or October of 1666. The name of his wife is given as Dorothy who died January 27, 1664 or 1665. It is noted that their first child was a daughter named Ann who maried William Allen.

<sup>\*</sup>There was another William Allen who was in Salem in 1626, and had children born 1632-49; also still another made his will in Boston, Dec., 1674, without children, or perhaps only one. A Wm. Allen took oath of freemen May 18, 1631. A John Allen had children rec. at Newbury, 1656-62. Walter Allen, chil. in Newbury, 1641-47. [C Nb.]

Edward Allen, of Ipswich, mar. Sarah Kimball, Nov. 24, 1658; had children born there 1659-78; rem. to Suffield. [Savage.]

We do not know that any of these were related to the Salisbury Allens.

In the will she mentioned her daughter, "Ruth hains"; grand-daughter "Sary Adhams"; "Thomas Adham's wife and Samuel Adhams my two grandchildren"; "grandson Goodhew"; "those three of my children that are deceased and left children"; "the part which should be to my daughter [Courrer's?] children, to my grand-daughter Goodhew's child which she had by John."

Oct. 30, 1684[S], Maj. ROBERT<sup>2</sup> PIKE (John<sup>1</sup>). No children.
- 1 Mrs. ELIZABETH GOODALE came from Yarmouth, Eng., in the "Mary Ann," in 1637; d. in Newbury, April 8, 1647[Nb]. She was wid. of John Goodale of Yarmouth, whose will was dated 1625. Children:
